Background

One of the final recommendations of the Children Services Transformation (CST) Advisory Council specific to Kinship was to identify collaborative strategies for family-finding in other systems. The goal for this CST recommendation is to review current family-finding efforts across other systems, such as child support, and use these opportunities to strengthen Ohio's family-finding process. The Kinnect to Family initiative (formerly 30 Days to Family), is being implemented and directed by Kinnect. As such, one of their tasks as it relates to this CST recommendation was to create guidance documents to include description of services, i.e. Connect our Kids family finding tool, Kinnect resources, LexisNexis, etc. This work has been ongoing and Kinnect has recently released these documents which ODJFS is pleased to share in this PPGD. These include resources for technology use, social media use, searching tips, genogram building, and platform supports for Connect our Kids, Accurint, GenoPro, and Facebook. Each of these document resources is outlined with a brief description and the documents are included as attachments to this PPGD.
